#### Bikeability Level 3 Course



Has your child achieved Bikeability Level 1 & 2? If so, they have the opportunity to complete the Bikeability Award scheme by undertaking Level 3 training.

Level 3 equips riders with the skills to tackle more complex roads and traffic situations. Included is:

- Using the best riding position for any situation
- Riding alongside other cyclists
- Riding on my complex roads
- Negotiating more complex roads such as junctions controlled by traffic lights, multi-lane roads and cycle lanes
- Route planning

Please check your child's cycle before the start of the course. If the bicycle is not roadworthy, pupils won't be able to participate in the course. Faults are often easily fixed but occasionally a new part from a bike shop is required so please check your child's cycle well in advance.
